



Motor Oil Limited Warranty

This Limited Warranty (“Warranty”) applies to PEAK® Motor Oil (individually and collectively, “PEAK Motor Oil” or “Product”) and includes all the terms and conditions stated below. This Warranty is free. No one may charge a fee for it.

Old World Industries, LLC (“Old World”) warrants to the owner of the vehicle (“Vehicle Owner”) that it will pay for the repair or replacement, at Old World’s option, of those vehicle engine components typically lubricated by motor oil (“Engine Component(s)”) that are damaged as a direct result of using PEAK Motor Oil; provided that: (1) the damaged Engine Components were properly used and maintained in accordance with the vehicle manufacturer’s specifications and recommendations; (2) Peak Motor Oil was installed, used and maintained in accordance with the vehicle manufacturer’s specifications and recommendations and in accordance with Old World’s specifications and directions on the Product label; (3) the vehicle was used under normal operating conditions and in accordance with the vehicle manufacturer’s specifications and recommendations and with Old World’s specifications; (4) the Vehicle Owner has maintained records verifying the conditions set forth in items (1) through (3) above; and (5) the Vehicle Owner certifies that no other products have been added to the Peak Motor Oil in question. In no event will any claim payment (parts and labor) be made in an amount exceeding \$5,000.00.

THIS WARRANTY IS THE ONLY EXPRESS WARRANTY THAT APPLIES TO PEAK MOTOR OIL AND SETS FORTH ALL OF THE OBLIGATIONS AND RESPONSIBILITIES OF OLD WORLD. IT COVERS ONLY DAMAGE TO THE ENGINE COMPONENTS LUBRICATED BY PEAK MOTOR OIL (PARTS AND LABOR ONLY) AS DEFINED ABOVE. ANY AND ALL APPLICABLE IMPLIED WARRANTIES ARE LIMITED TO THE TERMS, CONDITIONS AND DURATION OF THIS EXPRESS WARRANTY. ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, ARE SPECIFICALLY DISCLAIMED INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. CONSEQUENTIAL, INCIDENTAL, INDIRECT, PUNITIVE OR SPECIAL DAMAGES (INCLUDING LOST PROFITS, LOST BUSINESS OPPORTUNITIES OR LOSS OF USE) ARE SPECIFICALLY EXCLUDED FROM COVERAGE UNDER THIS WARRANTY.

State law rights: This Warranty gives you specific legal rights, and you may also have other rights which vary from state to state. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

To make a valid Warranty claim, the Vehicle Owner must do all of the following:

1. Notify Old World within thirty (30) days of discovering the damage and present the documentation required in item (4) above. Please send the required claim information to:

2. Provide proof of product purchase and a sample of the PEAK Motor Oil actually used in the damaged Engine Component for testing purposes.

3. Allow Old World or its designated agent(s) to inspect and test the Engine Components and associated vehicle claimed as damaged and take samples if necessary to determine whether PEAK Motor Oil was the cause of such claimed damage.
